Instructions on How to Vote – Proxy voting Form

Members not able to attend the AGM may choose to appoint proxy to cast a vote on their behalf.

Completion of the Proxy voting form

Appointment of a proxy

Members may choose either to appoint

- The Chairman OR
- A nominated person

By placing a corresponding mark in the relevant box. This section must be completed.

Voting for Candidates

Election of Directors is based on the most votes. There are no preferences

A member may choose at their discretion to leave this section blank. If a member leaves this section blank they agree to allow their proxy to vote in any manner at their discretion.

A member may choose to direct their proxy to vote in a particular manner by placing a mark in a box next to the candidate they wish to vote for. Only one (1) candidate should be chosen. Marking additional boxes will make the proxy invalid.

Completed and duly signed proxy forms must be received by the Returning Officer by the time period specified on the proxy voting form. They may be presented in person to the Returning Officer, by email or by post.

Proxy forms sent by post should be marked attention to the Returning Officer, PO Box 159 Strawberry Hills 2012.

I served with the NSW Ambulance Service since April 1974 (Volunteer/Honorary Officer) until November 1975 when I joined the permanent staff at Bomaderry in the Shoalhaven District. I completed my Intensive Care Paramedic Course in October 1979 and went on to fill positions at Wollongong, Dubbo (S/O1 and S/O11), Paramedic Educator at RNSH and AEC Rozelle, District Inspector Sydney, A/Operations Manager Sydney, Zone Manager Southern Division. I retired from the NSWAS in July 2013.

I was awarded the Ambulance Service Medal on the 26th January 2009.

During this time I held positions on the Board of the Institute of Ambulance Officers and Australian College of Ambulance Paramedics.

In 2009, I was elected to the Board of the Ambulance Provident Fund a position which I held until my resignation from the Board on the 29th September 2014.

During my Service with NSWAS, I was on numerous committees and inter service work groups.

I am currently employed as the Motorsport Manager with Motorsport Safety and Rescue.
