Dear Members,

It is a pleasure to present my report to you for the 2023-24 financial year. Continuing with tradition, the year can only once again be described as a great success for the APF!

Overview:

Whilst the business model of the APF is reasonably simple, there is a lot of work that goes into ensuring the entity is always performing well and is in a strong position to undertake the aims and goals it strives to achieve. This year has once again been an extremely positive year with our growth continuing month on month and year on year. Some highlights and points of interest are:

- Increased membership with new members joining at all NSWA induction courses.
- Increase in Gross worth currently more than \$9.6M.
- Increase in Net worth up by 9.45% to more than \$8.6M.
- All asset classes showing an increase in value (cash, shares, property & gold).
- An increase in asset diversification to protect funds overall.
- Excellent member value at still only \$3 per week per member!
